Crane Copper Tube Compliance and Limited Warranty Statement

Compliance

Copper tube supplied by Nungwon Metal Ind. Co., Ltd and owner of the brand “CEM” and “Crane Copper Tube” is complies with **ASTM B280**. This Standard specifies the required chemical composition, dimensions, tolerances, markings and mechanical properties for the copper tube. All Crane Enfield Metals **ASTM B280** copper tubes are marked as per the standard including the manufacturer’s trademark and country of origin.

Nungwon Metal Ind. Co., Ltd supplies copper tubes manufactured under Quality management System certification to ISO 9001:2008 issued by SBCR.

Limited Warranty

Nungwon Metal Ind. Co., Ltd provides a 25 year warranty that its **ASTM B280** copper tube will be manufactured to this standard, and if testing demonstrates that this standard has not been met, Nungwon Metal Ind. Co., Ltd will replace the copper tube subject to the following conditions:

1. The warranty does not cover non-compliance caused or contributed to, in whole or in part by, or arising from, any of the following:

- a) Abuse, misuse or neglect
- b) Incorrect installation
- c) System design
- d) Use other than for its intended purpose
- e) Natural disasters such as without limitation flooding, windstorms and lightning
- f) Damage caused by:
 - i. Chemical composition of the water being carried by the copper tube
 - ii. External environment in which the copper tube is situated
- g) Alterations to the copper tube by any person other than Nungwon Metal Ind. Co., Ltd (including without limitation) the removal of any trademark or other identifying marks.

Further Warranty Conditions

1. **Making a Claim:** A Warranty claim by a customer can be made by forwarding a letter containing details of the defect to the address referred to below within 30 days of the defect becoming known to the customer, together with proof of purchase documents evidencing the date and place of purchase and the date of delivery or sale.

2. **Expenses:** If the Warranty claim is accepted by Crane Copper Tube, expenses associated with the claim shall be paid by Crane Copper Tube. If the customer has incurred such expenses (with the consent of Crane Copper Tube) it shall supply evidence of those expenses (and payment) to Crane Copper Tube who may accept such evidence and reimburse the customer. *Expenses do not include claims for damages or loss, but only claims associated with investigation of the Warranty claim and repair or replacement of the product.*
